## Health and Safety at Work (Hazardous Substances—Certified **Handler of Class 6 Substances Compliance Certification**) **Amendment Performance Standard 2022**

### Performance standard

#### 1 Title

This is the Health and Safety at Work (Hazardous Substances—Certified Handler of Class 6 Substances Compliance Certification) Amendment Performance Standard 2022.

#### 2 Commencement

This performance standard comes into force on

### 3 Principal performance standard

This performance standard amends the Health and Safety at Work (Hazardous Substances—Certified Handler of Class 6 Substances Compliance Certification) Performance Standard 2019.

### 4 Clause 4 amended (Interpretation)

- (1) In clause 4(1) amend the definition of **agrichemical**, paragraph (d), by deleting "as defined in NZS 8409—2004".
- (2) In clause 4(1) insert in its appropriate alphabetical order:

"agricultural context includes any activity involving the management of land and water resources in the production of animals or plant crops up until the point of slaughter or harvest"

### 5 Clause 5 amended (Evidence required to demonstrate competency)

In clause 5(1)(a) insert ", marriage certificate" after "passport".

### 6 Clause 12 amended (Scope of certification)

- (1) Replace clause 12(3)(a) (including the example) with:
  - "(a) in relation to the name and classification of an agrichemical,—
    - (i) if the substance is classified as a class 6.1A substance—
      - (A) the chemical name of the active ingredient used as the agrichemical; and
      - (B) the classification 6.1A:
    - (ii) if the substance is classified as a class 6.1B substance—
      - (A) the word 'Agrichemicals'; and
      - (B) the classification 6.1B:"
- (2) In clause 12(2) replace "(5)" with "(5D)".
- (3) After clause 12(5) insert:

"(5A) In the case of a class 6 substance other than an agrichemical, a fumigant, or a vertebrate toxic agent, where the substances are kept at a bulk commercial storage or transit depot, instead of the name of the substance, the compliance certifier may record—

- (a) the description "acutely toxic substances"; and
- (b) the classifications 6.1A and 6.1B.
- (5B) Subclause (5A) only applies if the applicant is seeking certification for the life cycle phase storage and/or transport only.
- (5C) In the case of a class 6 substance other than an agrichemical, a fumigant, or a vertebrate toxic agent, where the substances are stored or used at a dedicated waste disposal site, instead of the name of the substance, the compliance certifier may record—
- (a) the description "acutely toxic substances"; and
- (b) the classifications 6.1A and 6.1B.
- (5D) Subclause (5C) only applies if the applicant is seeking certification for the life cycle phase storage and/or disposal only."

#### 7 Clause 13 amended (Other information to be recorded)

In clause 13(2) delete paragraph (b) and paragraph (c) (including the example).

# 8 Schedule 1 amended (Additional provisions: verifying competency requirements for certified handler of agrichemicals)

- (1) In Schedule 1, clause 3(d), replace "aid." with "aid; and".
- (2) In Schedule 1, after clause 3(d), insert:
  - "(e) safe handling techniques and processes for the manufacture of the substance, where applicable."

# 9 Schedule 2 amended (Additional provisions: verifying competency requirements for certified handler of fumigants)

- (1) In Schedule 2, clause 3(j), replace "limits." with "limits; and".
- (2) In Schedule 2, after clause 3(j), insert:
  - "(k) safe handling techniques and processes for the manufacture of the substance, where applicable."

# Schedule 3 amended (Additional provisions: verifying competency requirements for certified handler of vertebrate toxic agents)

- (1) In Schedule 3, clause 3(e), replace "applicable." with "applicable; and".
- (2) In Schedule 3, after clause 3(e), insert:
  - "(f) safe handling techniques and processes for the manufacture of the substance, where applicable."

# Schedule 4 amended (Additional provisions: verifying competency requirements for certified handler of other class 6 hazardous substances)

- (1) In Schedule 3, clause 3(f), replace "substance." with "substance; and".
- (2) In Schedule 3, after clause 3(f), insert:
