Notice of Exemption

In accordance with section 220 of the Health and Safety at Work Act 2015 (the Act), Chorus New Zealand Limited is exempted from compliance with regulation 17.63(4)(a)(ii), 17.63(4)(b), and 17.92(2)(b)(i) and (ii) of the Health and Safety at Work (Hazardous Substances) Regulations 2017 for each of their stationary container systems with the serial number listed in column 1, Annex 1 ("the tank"), that is located at each site listed in columns 2 and 3 of Annex 1 ("the site"), subject to the following conditions -

Chorus New Zealand Limited must, for each site -

- ensure the tank is not filled beyond 420 litres (the maximum the tank can be filled by virtue of the design of the tank); and
- (2) ensure the tank is located such that a person can exit the building without passing within2 metres of the tank; and
- ensure the floor under and about the tank is made of masonry or reinforced concrete;and
- (4) ensure that only persons who are regularly employed in telephone exchanges or are accompanied by persons who are regularly employed in telephone exchanges may be present in the room in which the tank is installed; and
- (5) ensure persons in the room in which the tank is installed are limited to those who are essential for the operation and maintenance of the site; and
- no later than 31 November 2023, initiate a system of an annual regular integrity checks to verify principal prescribed requirements of Part 17 of the Regulations; and
- no later than 31 November 2023, provide to WorkSafe
 (hsapplications@worksafe.govt.nz) a plan specifying a time by which the non-compliant matters of Part 17 of the Regulations (with the exception of the exempted matters of regulation 17.63(4)(a)(ii), 17.63(4)(b), and 17.91(2)(b)(i) and (ii)) shall be bought into compliance; and
- (8) provide a copy of this exemption to any compliance certifier engaged to issue a location compliance certificate (if required) or a stationary container system compliance certificate; and

(9) hold a copy of this exemption at the site.

This exemption takes effect from the date specified in the *Gazette* notice required by section 221 HSWA, which will be on 4th July 2023 and expires on 4th July 2028 unless it is replaced sooner or revoked. This exemption is given the reference HS2119.
