Safe Work Instrument

1 Title

This is the Health and Safety at Work (Hazardous Substances—Requirements for Approving a Type of Burner) Safe Work Instrument 2025.

2 Commencement

This safe work instrument comes into force on 30 June 2025.

3 Interpretation

(1) In this safe work instrument, unless the context otherwise requires,—

Act means the Health and Safety at Work Act 2015

AS 1375:2023 means the Australian Standard on Industrial fuel-fired appliances

BS EN 267:2020 means the British/European Standard on Forced draught burners for liquid fuels

NFPA 86:2019 and NFPA 86:2023 means the National Fire Protection Association Standard for Ovens and Furnaces

Regulations means the Health and Safety at Work (Hazardous Substances) Regulations 2017

UL 296A:2018 (3rd Edition) means the Standard on Waste Oil-Burning Air-Heating Appliances published by UL LLC.

(2) A term or expression that is defined in the Act or the Regulations and used, but not defined, in this safe work instrument has the same meaning as in the Act or the Regulations.

4 Burner approval requirements

For the purposes of regulations 11 and 17.67(5)(j) of the Regulations, a burner that does not comply with a standard specified in regulation 17.67(5)(a) to (i) must comply with the requirements in one of the following standards—

- (a) AS 1375:2023; or
- (b) BS EN 267:2020; or
- (c) NFPA 86:2019; or
- (d) NFPA 86:2023; or
- (e) UL 296A:2018 (3rd Edition).
